



Terms & Conditions of NETS x Seoul Garden Return Voucher Promotion (1 May 2025 – 30 April 2026)

The NETS x Seoul Garden Return Voucher Promotion (“**Promotion**”) is carried out by Network for Electronic Transfers (Singapore) Pte Ltd (“**NETS**”) and Zingrill Pte Ltd which operates under the trading name of Seoul Garden (“**Seoul Garden**”) and is subject to these terms and conditions (“**Terms**”).

1. This Promotion is applicable to Seoul Garden customers who make NETS payments using the following cards and mobile applications:
 - a. NETS payment using DBS-NETS/ POSB-NETS/ HSBC-NETS/ OCBC-NETS/ Maybank-NETS/ Standard Chartered-NETS/ UOB-NETS ATM, debit, credit cards issued by DBS, POSB, HSBC, OCBC, Maybank, Standard Chartered and UOB in Singapore (“**Participating Banks**”), as well as NETS FlashPay Card, NETS Motoring Card and NETS Prepaid Card; and
 - b. NETS QR payment using DBS PayLah!, DBS digibank mobile app, POSB digibank mobile app, UOB TMRW, OCBC app, Maybank2u SG and NETS App.
2. Valid from 1 May 2025 – 30 April 2026, both dates inclusive (“**Promotion Period**”) unless otherwise agreed in writing between NETS and Seoul Garden. While stocks last.
3. The Promotion is valid at all Seoul Garden and Seoul Garden HOTPOT outlets in Singapore which are registered with NETS and/or the Participating Banks and accepts NETS payment Please visit <https://www.nets.com.sg/SeoulGarden> for list of participating outlets (“**Participating Outlets**”).
4. NETS may from time to time, in its absolute discretion decide on the eligibility of a Participating Outlet or a customer for participation in the Promotion.

Promotion Mechanics:

5. Customers paying with NETS are eligible to receive one (1) \$20 return voucher at Seoul Garden outlet **OR** one (1) \$10 return voucher at Seoul Garden HOTPOT outlet during the Promotion Period (“**Qualifying Transaction**”), while stocks last, which they can use/redeem the return voucher at their next visit to Seoul Garden. To use/redeem a return voucher, the following minimum spend applies: \$100 at Seoul Garden outlet and \$50 at Seoul Garden HOTPOT outlet.
6. Promotion is not valid in conjunction with other promotions. All promotions are mutually exclusive.
7. The Promotion is strictly non-refundable, i.e. the return vouchers cannot be refunded in cash.
8. If any Qualifying Transaction is cancelled or reversed during the Promotion Period, the customer will not be considered to have met the Qualifying Transaction. In this event, the return voucher received by the customer will be forfeited and cancelled by Seoul Garden.
9. Seoul Garden & NETS reserve the right to partially or completely cancel, terminate or suspend the Promotion for any reason without any liability whatsoever.
10. Seoul Garden’s & NETS’ decisions on all matters pertaining to the Promotion are final and binding. No further correspondence regarding the Promotion, these Terms or any decision made by Seoul Garden or NETS in connection therewith and/or the results will be entertained.
