

Terms & Conditions of NETS Motoring Card Lucky Draw 2025 – Win A Year’s Worth of Free Petrol or EV Charging (1 June 2025 – 31 December 2025)

The NETS Motoring Card Lucky Draw 2025 – Win A Year’s Worth of Free Petrol or EV Charging (“**Lucky Draw**”) campaign is carried out by Network for Electronic Transfers (Singapore) Pte Ltd (“**NETS**”) and is subject to these terms and conditions (“**Terms**”).

1. The Lucky Draw campaign is open to all users of NETS Motoring/ NETS FlashPay Card (“**Cardholders**”). NETS employees, and their immediate family members are not eligible to participate in this Lucky Draw.
2. The Lucky Draw campaign is valid for 7 months, from 1 June 2025 - 31 December 2025, both dates inclusive (“**Campaign Period**”).
3. NETS may from time to time, in its absolute discretion, decide on the eligibility of a Cardholder for participation in the Lucky Draw.

Qualifying for the Lucky Draw

4. Cardholders must register for the Lucky Draw and top up their NETS Motoring/ NETS FlashPay Card (“**Motoring Card**”) within the Campaign Period to qualify for the Lucky Draw (“**Qualifying Transaction**”). To register for the Lucky Draw, Cardholders must submit their contact details, Motoring Card 16-digit CAN ID and accept the terms and conditions of the Lucky Draw. Top-ups prior to or after the Campaign Period will not earn any Lucky Draw chances.
 - a) **2 Lucky Draw chances** will be awarded for every **\$50 top-up via Auto Top-up service** and **NETS payment on NETS App** (i.e. payment via DBS, OCBC, POSB and UOB ATM/ Debit cards added to Payment Method).
 - b) **1 Lucky Draw chance** will be awarded for every **\$50 top-up via all other NETS Motoring/ NETS FlashPay Card top-up channels** (i.e. NETS top-up machines, convenience stores, ATMs of local banks and top-ups with Amex/ Mastercard/ Visa cards on NETS App).
5. The Campaign Period is divided into two (2) qualifying rounds. Round 1 will be from 1 June 2025 – 31 August 2025 and round 2 will be from 1 September 2025 – 31 December 2025.
6. Motoring Cards which are terminated and refunded within the Campaign Period, either by NETS or the Cardholder, will be disqualified from the Lucky Draw, unless the registered card is examined and certified by our Customer Service Centre to be faulty and in need of replacement. If the registered card is voluntarily or involuntarily terminated or blocked for use for any reason whatsoever before the Winner has taken possession of the Lucky Draw Prize, NETS reserves the right not to award the Lucky Draw Prize to the Winner.

Lucky Draw Prizes

7. There will be two (2) computerised Lucky Draws to select winners for the following prizes:
 - a) First draw within two (2) months after the end of qualifying round 1:
20 winners of \$1,000 worth of fuel vouchers/ charging credits or equivalent
 - b) Second draw within two (2) months after the end of qualifying round 2:

More chances to win as there are **23 winners**

- **3 grand prize winners of \$4,000 worth of fuel vouchers or 2,500kwh charging credits**; and
 - **20 winners of \$1,000 worth** of fuel vouchers/ charging credits or equivalent
8. Each Cardholder is eligible to win only one (1) prize, and has the option of choosing either fuel vouchers or charging credits, regardless of the number of Motoring Cards registered for this Lucky Draw campaign.
 9. NETS will conduct the Lucky Draws at its office in the presence of an independent auditor. For the purposes of identification and verification, the names and the last 4 digits of mobile number of the winners for the Lucky Draws will be shared in the winners' official announcement published on the NETS website (www.nets.com.sg).
 10. Winners will be notified via calls to their registered mobile number, messages through SMS, WhatsApp or email. Winners shall respond to NETS' notification in accordance with the instructions provided by NETS within seven (7) calendar days from the date of notification, failing which NETS shall be entitled to disqualify the winner without further notification. In the event of a winner's disqualification, NETS will select a replacement winner from the list of reserve winners drawn. Upon the selection of the replacement winner, all references to "winner" in these Terms shall refer to the replacement winner.
 11. All prizes for the Lucky Draws ("**Prizes**") are not transferable or exchangeable for cash, credit or in kind and is subject to the terms herein. Winners shall be responsible for all ancillary and additional costs arising from the use of the Prizes insofar as these are not specifically indicated as part of the Prizes.
 12. All Prizes shall be deemed as received in good order by 30 April 2026. No correspondence or claims regarding the Prizes will be entertained after this date. Winners shall not be entitled to any payment or compensation whatsoever from NETS. NETS shall under no circumstances whatsoever be liable for any invalid, forfeited or unredeemed claim or prize.
 13. Winners shall not hold the issuer of the fuel vouchers/ charging credits, a known petrol brand company in Singapore and its related corporations and/or their respective officers, employees or directors responsible or liable for, or look to the company for any losses, claims or liabilities arising from: (i) forfeiture of the Lucky Draw prize; or (ii) the conduct of the Lucky Draw.
 14. NETS reserves the right to, at any time and in its sole and absolute discretion, replace and/or substitute the Prizes with an alternative item of any value without prior notice and without any liability.
 15. NETS makes no warranty or representation (whether express or implied) on the quality, merchantability or suitability for use of the Prizes. NETS shall not be liable for any loss, injury or damage that may be suffered or incurred by any person in connection with these Prizes or the use of the Prizes.

Personal Data Consents

16. By participating in the Lucky Draw and/or claiming the Prizes, winners give consent to NETS and related corporations, affiliates, business partners, service providers and agents to collect, use and disclose his or her name and personal data and particulars, including but not limited to, personal identification information, contact details and photographs (for identification purposes) in accordance with the Personal Data Protection Act 2012 and the purposes set out in the NETS Privacy Policy (available at <https://www.nets.com.sg/policies/data-protection>) in connection with the conduct of the Lucky Draw and/or registration and delivery of the Prizes to the winners.

17. Winners additionally consents to the collection, use and disclosure of his or her name, personal data and particulars, photograph and voice by NETS and related corporations, affiliates, business partners, service providers and agents in newspapers, radio, social media and other media as may be determined by NETS, and to be photographed, filmed and/or interviewed for publicity, sales and marketing and promotional purposes in connection with the conduct of the Lucky Draw and/or registration and delivery of the Prizes to the winners without any compensation.
18. A Cardholder may update his/ her personal data entered for the Lucky Draw or withdraw his/ her consent provided to NETS at any time via marketing@nets.com.sg. NETS will process such Cardholder's request within a reasonable time from such a request being made. Any Cardholder who has withdrawn his/ her consent shall be deemed as disqualified from the Lucky Draw upon his/ her submission of withdrawal of consent.
19. Cardholders who enter this Lucky draw represent and warrant that the personal data and particulars disclosed to NETS during the Lucky Draw registration process is true, complete and accurate. NETS shall not be held liable and shall be fully indemnified by the Cardholders for any incorrect or inaccurate personal data provided.
20. If a Cardholder is entering the personal data on behalf of a third party (e.g. information of Cardholder's dependent, spouse and/ or parents) for the Lucky Draw, the Cardholder represents and warrants that the collection, use and disclosure of that personal data to NETS, as well as the further processing of that personal data by NETS for the purposes set out in this Policy, is lawful.
21. NETS reserves the right to request for Cardholder's proof of identity for the purpose of verifying the Cardholder's eligibility for this Lucky Draw or claim to the prize. In the absence of such verification, NETS shall be entitled in their discretion to disqualify the eligible Cardholder from the Lucky Draw, and the eligible Cardholder shall have no claim whatsoever against NETS in such event.
22. If a Cardholder has opted in for additional marketing and promotional content during the Lucky Draw registration process, he/ she consents to the collection, use or disclosure of his or her personal data and particulars by NETS and related agents, business and marketing partners and authorised service providers for the purposes of (a) sending marketing and promotional materials relating to NETS's products and services, benefits, promotions and rewards to the Cardholder, and (b) conducting market research and statistical analysis.
23. By entering this campaign, Cardholders or participants acknowledge that they have read and understood NETS' Data Protection Policy (as published in NETS' website), and consent to the collection, use and disclosure of their personal data by NETS for the purposes set out in these Terms. Rights and Liability of NETS

24. NETS reserves the right to disqualify an otherwise eligible Cardholder from winning the Prizes and/ or substitute another Cardholder as a winner in the event that NETS in its absolute discretion believes that the particular Cardholder may have contravened, will contravene or has contravened any of these Terms and/ or may bring NETS into disrepute.
25. NETS reserves the right to partially or completely cancel, terminate or suspend the Lucky Draw for any reason without any liability whatsoever.
26. NETS' decisions on all matters pertaining to the Lucky Draw are final and binding. No further correspondence regarding the Lucky Draw, these Terms or any decision made by NETS in connection therewith and/ or the results will be entertained. NETS reserves its absolute right to determine an outcome and act as it deems fit in any dispute and/or issues relating thereto.

27. NETS shall not be liable to any person in any way for any loss or damage howsoever arising from or in connection with the Lucky Draw and/or the Prizes.
28. NETS reserves the right at any time to amend or delete these Terms and/or any of the instructions or explanations at its sole discretion without prior notice. Any such changes shall be binding and will take effect immediately upon such amendment, change or deletion. Participation in this Lucky Draw shall constitute acceptance of these Terms and any amendment(s) thereof.
29. To the extent permissible by law, NETS shall not be liable or responsible for any acts or omissions in connection with this Lucky Draw (including without limitation any collection, use, disclosure and/or processing of any participant's personal data in connection with this Lucky Draw).
